6 A person whose permission for a secondhand articles business has been rescinded pursuant to the provisions of Article 24, and for whom five years have not passed from the date of the rescission (for a juridical person, this includes a person who held office at the juridical person as an executive officer within 60 days prior to the day on which public notice of the date and place of the hearing pertaining to the rescission was publicly given, and for whom five years have not passed from the date of the rescission.)

7 A person who has returned the permission certificate under the provisions of Article 8 paragraph 1 item (i) during the period starting from the day on which public notice of the date and place of the hearing pertaining to the rescission of the permission under the provisions of Article 24 was given to the day on which the rescission is exercised or the day on which a decision not to exercise the rescission is made (excluding those for whom there are reasonable grounds for discontinuing the secondhand articles business) and for whom five years have not passed from the date of the return.

8 A person specified by the Rules of the National Public Safety Commission as a person who is unable to properly conduct the business of a secondhand articles dealer or a secondhand articles market owner due to a mental or physical disorder.

9 A minor who does not have the same capacity as a person who has reached the age of majority with regards to the business; provided, however, that this does not apply to cases in which the person is an heir of a secondhand articles dealer or a secondhand articles market owner, whose statutory agent does not fall under any of the a/m No.1 to 8.
